TERMS AND CONDITIONS

- 1. Each Bidder should BID in lump-sum and send the Quotations through courier BOQ in the aforesaid address. Price must not be quoted in Technical BID. Rates is to be quoted in INR only.
- 2. The following documents should be submitted through courier only.
 - a) Authenticated copy of a certificate showing performance of this type of supply in the past e.g. copy of purchase order.
 - b) Authenticated Technical BID as per Annexure-II
 - c) Declaration as per Annexure-IV
- 3. The schedule of supply and specification of items are enclosed in Annexure-III. The rate should be quoted including transportation cost at the project location Udaipur, Gomati District of 40 units.
 - 4. Tender once submitted should remain valid at least 30 (thirty) days for acceptance.
 - 5. The BID should contain two envelopes containing the Technical BID and Financial BID in the form of BOQ.
 - 6. Rates quotes for the item should include the taxes/duties and transportation cost/delivery cost/packaging etc.of the items at the mentioned places. Taxes/duties and transportation costs are to be included in the amount quoted the BOQ and no subsequent claims for taxes/duties transportation cost etc. will be entertained separately.
 - 7. Maximum of 40% of the total contract value will be released to the supplier post signing the contract, and the remaining post receiving the material and final clearance given by the program team on written that delivery has been made as per terms and conditions of the contract.
 - 8. The supplier will have to arrange for Road Permit/E-Way Bills if required for the supply of the item/s.
 - 9. The Purchase Committee of the Centre for Micro Finance and Livelihood reserves the right to accept any or all tenders either in part or in full without assigning any reasons whatsoever.
 - 10. The Aerators should be delivered within 40 to 45 days to the said locations after receiving the purchase order (PO). If the items are not delivered within the stipulated period of time a penalty will be charged @₹500 per day from the supplier.
 - 11. Once the items are delivered to the project location, the Purchase Committee will nominate a Technical Person who will verify and certify the materials as per the specification of PO.
 - 12. Tax deduction at source will be made wherever applicable.
 - 13. The organization has all the rights to cancel/withdraw the tender at any point in time
