**Subject: Quotation for Supplying 6 Lakhs of IMC Fish Seed ( Catla-1,80,000 Pices, Rohu-2,40,000 Pices & Mrigal- 1,80,000 Pices) under CSAL Tripura Project.**

Centre for Microfinance and Livelihood (CML) invites Quotations through an closed tender system in 2 (two) BID systems from the Authorized Dealers/Reputed Hatcheries as per the specification at Annexure-III. #### TERMS AND CONDITIONS

1. Each Bidder should BID in lump-sum and send the Quotations to [admin@cmlnortheast.com](mailto:admin@cmlnortheast.com). The price must not be quoted in Technical BID. Rates to be quoted in INR only.
2. The following documents should be submitted along with all the authenticated documents:
  - a) Authenticated copy of a certificate showing performance of this type of supply in the past e.g., copy of purchase order.
  - b) Authenticated Technical BID as per Annexure-II
  - c) Declaration as per Annexure-IV
3. The schedule of supply and specification of items are enclosed in Annexure-III. The rate should be quoted including transportation cost at the project location in Manu & Chawmanu Blocks, Dhalai Tripura, Tulashikhar & Padmabil Blocks, Khowai Tripura and Mohanbhog & Khatalia Blocks, Sepahijala Tripura.
4. Tender once submitted should remain valid for at least 45 (Forty Five) days for acceptance.
5. Rates quotes for the item should include the taxes/duties and transportation cost/delivery cost/packaging etc.of the items at the mentioned places. Taxes/duties and transportation costs are to be included in the amount quoted the BOQ and no subsequent claims for taxes/duties transportation cost etc. will be entertained separately.
3. Maximum of 30% of the total contract value will be released to the supplier post signing the contract, and the remaining post receiving the material and final clearance given by the program team on written that delivery has been made as per terms and conditions of the contract.
6. The supplier will have to arrange for Road Permit/E-Way Bills if required for the supply of the item/s.
7. The Purchase Committee of the Centre for Micro Finance and Livelihood reserves the right to accept any or all tenders either in part or in full without assigning any reasons whatsoever.
8. The material should be delivered within 25 to 30 days to the project location after receiving the purchase order (PO) along with desired advance amount. If the items are not delivered within the stipulated period of time a penalty will be charged ₹200 per day from the supplier.
9. Tax deduction at source will be made wherever applicable.
